Letter of Guaranty

Mid-State Auto Auction (a Bob Thompson Motor Co. company)

In consideration of the Auction allowing Dealer to buy and sell motor vehicles through the Auction, the undersigned, whether one or more, personally covenant, guarantee and warrant that the title to each vehicle sold by Dealer through Auction will be good and will be free and clear of all liens and encumbrances, whatsoever. The undersigned agrees to reimburse Auction for any loss, damage, expense, or costs, including attorney's fees, incurred by Auction as a result of breach of the foregoing warranty as to any such motor vehicle. The undersigned further guarantees full payment of any debts of Dealer to Auction, including any checks or drafts issued by Dealer or any Dealer's representatives, together with any loss of expense incurred by Auction in collecting or attempting to collect such debt, including attorney's fees.

The undersigned acknowledges that Auction shall have the right to refuse to transact with Dealer, to modify or release any and all collateral security, to extend or charge time if payment and to settle or compromise with Dealer without notice to the undersigned and without discharging to affecting the liability of the undersigned hereunder. The guaranty is to be a continuing guaranty and the undersigned herby waives notice of acceptance of this guaranty and presentment, demand, protect, and any notice of non-payment of dishonor. The undersigned shall be liable as principal debtor and not merely as surety and the bankruptcy or any assignment in favor of Creditors or Dealer shall not affect the enforcement of the agreement.

It is understood and agreed between the Seller, the Purchaser, and Mid-State Auto Auction that the Auction does NOT provide insurance for theft, fire, hail, or any other damage to a motor vehicle. Mid-State Auto Auction is NOT RESPONSIBLE for the loss of, or damage to a vehicle because of theft, fire, hail, or other damage to a motor vehicle. Mid-State Auto Auction does NOT furnish liability insurance while said vehicle is being operated, either on or off public streets and highways.

While Mid-State Auto Auction does assist in locating drivers for Seller and Purchaser to drive vehicles to or from Mid-State Auto Auction's premises to the Seller and/or Purchaser's premises, such drivers are not employees of Mid-State Auto Auction and Mid-State Auto Auction acts only as Purchaser's and Seller's agent in disbursement of funds for services and payment for driver's services is the obligation of Sellers and Purchasers. Seller and Buyer are free to select other drivers of their own choice.

Seller also understands that Auction may, in its discretion, add gasoline to said vehicle and/or have said vehicle washed and seller herby accepts said vehicle in its' present condition and it is understood that removal of said vehicle from Auction premises shall preclude Buyer from asserting any and all claims concerning said vehicle.

The Buyer and Seller herby agree that Mid-State Auto Auction is acting and shall act as their mutual agent in the sale of a vehicle. Seller herby instructs Auction to sell said vehicle. Buyer and Seller herby state that they have read and understood the same and herby agree to be bound by the same as is fully incorporated herein. Said posted terms and conditions include but are not limited to Auction's commission schedule for sales and regulations for buy fees.

This instrument shall bind the respective heirs, executors, administrators, and assigns of the undersigned, and shall ensure to the benefit of the Auction, its' successors, assigns and subrogates.

Where there is more than one signatory to this agreement each signatory shall be severely liable under this agreement.
